2. Set-up begins at 10 AM. Display should be complete by 12:00 and must remain intact until 5:00 PM.
3. Sub-letting of spaces is not permitted.
4. Each vendor is responsible for collecting and reporting Pennsylvania Sales Tax.
5. Food Vendors must provide Food Safety License (if applicable). All food vendors are required to obtain a transient license from the Borough of Waynesboro (55 East Main Street, Waynesboro, PA • 717-762-2101).
6. Tables/chairs: Vendors are responsible for the tables and chairs for their display.
7. Clean up: You must clean up your designated area before you leave.

2. Checks made payable to *Mainstreet Waynesboro, Inc.*
3. **Application and payment must be received by 4/3/2026.**
4. All vendors are assigned spaces.
5. No refunds after being accepted. Refunds or credit will be given only if Mainstreet Waynesboro cancels the event.
